For and on behalf of the Director, ABV-IIITM, Gwalior, tenders are invited to auction **old/obsolete/non-working/un-serviceable IT equipment**. You are requested to quote your best offer for all the items in totality as per the terms & conditions. (Refer to details as per Annexure-I)

**The quotation should be sealed and superscripted with the tender number and addressed to the following:**

***The Registrar, ABV- Indian Institute of Information Technology & Management Morena Link Road, Gwalior Madhya Pradesh***

The sealed quotations should reach the Institute latest by **24th July 2024 at 04:30 PM, and they will be opened on 24<sup>th</sup> July 2024 at 5:00 PM** in Board Room Admin. Block, ABV-IIITM, Gwalior, in the presence of the bidder(s) or their authorized representative(s), if any, an Authorization letter is required who will have to be present at the scheduled date and time.

### **Terms & Conditions**

- 1. Security Deposit:** The bidder shall be required to submit the Security Deposit for **Rs. 2,500/- (Rupees Two Thousand Five Hundred Only)** by way of demand draft only. The demand draft shall be drawn in favor of "**Director, ABV-IIITM, Gwalior.**" The demand draft for the security deposit must be enclosed in the technical bid envelope only. The security deposit of the successful bidder shall be returned after the completion of the work. The Bid(s) received without a demand draft of the security deposit will be summarily rejected.

- a) The Firm that is registered with National Small Industries Corporation (NSIC) / OR Small Scale Industries (SSI) is exempted from submitting the security deposit (A copy of registration must be provided along with technical Bid), as per GoI norms
  - b) In case of unsuccessful Bidders, the security deposit shall be retained by ABV-IITM, Gwalior, till the finalization of the tender. No interest will be payable by ABV-IITM, Gwalior, on the SECURITY DEPOSIT.
2. **Rate:** Rate should be quoted in Indian Rupees (INR) on as is where is basis. Minimum reserve price for the items being auctioned is Rs 27252/-
  3. **Taxes:** Any taxes, if payable, should be borne by prospective bidders.
  4. **Opening of Tender:** The tenderer is at liberty either himself or to authorize not more than one representative to be present at the opening of the tender. The representative attending the opening of the tender on behalf of the tenderer should bring with him a letter of Authority from the tenderer and proof of identification. The late received tenders by ABV-IITM, Gwalior, will be ignored. Further, ABV-IITM, Gwalior does not accept any liability and responsibility for the tenders if the same is not properly sealed, marked, and sent as above.
  5. **Validity:** The quoted rates must be valid for 60 days from the date of closing of the tender. The overall offer for the bidder(s) quoted price shall remain unchanged during the validity period. If the bidder quoted validity shorter than the required period, the same will be treated as unresponsive and rejected.  
Suppose the tender has been given, and the tenderer withdraws, modifies or changes his offer during the validity period. In that case, Bid is liable to be rejected, and the security deposit shall be forfeited without assigning any reason.
  6. **Authority of person signing document:** A person signing the tender form or any documents forming part of the contract on behalf of another shall be deemed to warranty that he has the Authority to bid, and if, on inquiry, it appears that the person so, signing had no authority to do so, ABV-IITM, Gwalior may without prejudice to other civil and criminal remedies cancel the contract and held the signatory liable for all cost and damages.
  7. **Breach of Terms and Conditions:** In case of violation of any terms and conditions as mentioned above, the Competent Authority will have the right to reject the Bid at any stage without assigning any reason thereof, and nothing will be payable by ABV-IITM, Gwalior, in that event the SECURITY DEPOSIT shall also stand forfeited.
  8. The tenderers should furnish a copy of their PAN & GST registration. Tenders not complying with this condition will be rejected.
  9. Bidder shall submit a copy of the tender document and addendum/corrigendum to that, if any, with each page of this document should be signed and stamped to confirm the acceptance of the entire terms & conditions as mentioned in the tender document.
  10. After due evaluation of the bid(s) ABV-IITM, Gwalior will award the contract to the highest bidder.

- 11. Legal Jurisdiction:** Any disputes are subject to the exclusive jurisdiction of a competent court and forum in Gwalior, Madhya Pradesh, India, only.
- 12. Applicable Law:** The contract shall be governed by the laws and procedures established by Govt. of India within the framework of relevant legislation and enactment made from time to time concerning such Commercial dealings/processing.
- 13. Force Majeure:** Any delay due to Force Majeure will not be attributable to the seller.
- 14. Institute's Obligations:-**The Institute shall not pay any compensation for any injury or death caused to the Contractor's workers. It will be the sole responsibility of the Contractor.
- 15.** The prospective bidder shall bear transport and all contingency expenses.
- 16.** No bill for the items being auctioned shall be provided to the bidder.
- 17.** The successful bidder has to deposit the total amount within seven days of receiving the order for disposable/ auction of the unserviceable and non-working items.

**18. Criteria of Technical Eligibility:**

**For technical eligibility, the bidder should submit the following documents in the technical Bid envelope**

- a) The bidder should submit the registration certificate of the Firm
  - b) The bidder should submit PAN Card
  - c) The bidder should submit an Aadhaar card
  - d) The bidder should submit a service tax/GST registration certificate along with the tender documents
  - e) The bidder should have a demand draft of Rs 2500/-
  - f) The bidder should submit the bank details.
  - g) The bidder to submit certificate of undertaking (Annexure-2)
  - h) The bidder to submit technical eligibility details as per the checklist (Annexure-3)
- (The above said documents must be submitted in envelop-1 super scribing technical bid)*

**19. Financial Bid:** The bidder should submit Financial bid (Annexure-1) in envelop-2 super scribing Financial bid)

**Note:** The bidder must submit envelop-1 and envelop-2 in a big envelop super scribing auction of old/obsolete/non-working/un-serviceable IT equipment.

**20. Criteria for evaluation of the tender:** - The tender assessment will be made first based on technical information submitted by the bidders, and the Financial Bid will be opened only for the technically qualified/successful bidders.
