All the candidates who have accepted a seat during JoSAA, CSAB, DASA, SII counseling are required to report Institution on August 12-13, 2024.

Physical reporting to the Institute dates are 12-13 August 2024, and the academic registration date is 12th-13th August 2024. Most of you have paid the partial fees on the JoSAA portal, the remaining institute fee has to be paid, as applicable, according to the details of the fee given next pages during 8th -13th August 2024 through NEFT. Orientation followed by classes will begin from 12th August 2024. Every student will get hostel accommodation (sharing basis) upon their arrival at the Institution.
