# 1. Introduction: -

#### 2. NIQ Documents: -

#### 3. Place of supply and work: -

Supply of materials/labor will be made at Pocket – A and B campus of ABV-IIITM Gwalior, Morena Link road, Gwalior Madhya Pradesh - 474015.

#### 4. Site visit:

The bidder is advised to acquaint himself with the job work, visit the Site & examine site conditions, climatic conditions, labour, power, material availability, transport and communication facilities, environmental regulations, laws and bye- laws of statutory, local bodies and the Govt. of India and collect all information that shall be necessary for preparing the bid and entering into a contract. # 7. Procedure for tender submission: -

- b) All papers related to eligibility as per Annexure I (Page No. 17-18) along with EMD and tender fee shall be kept in envelop marked <u>"1" (Technical bid)</u> and closed the envelope properly and only Financial bid is to be kept in envelop <u>"2' Financial bid</u> marked financial Bid (The financial bid envelope must contain only the financial bid) and closed the envelope properly. - c) All pages of the Bid shall be duly numbered and self-attested by the bidder.
- d) Bidder shall quote the rate of all the items and accept all the terms and conditions of NIT failing which offer is liable to be rejected without any further communications.
- e) Xerox copies of all the submitted documents shall be self-attested.
- f) Conditional Bids will not be accepted.
- g) The tenderers shall submit the tender in two sealed envelopes marked as 1st and 2nd. The first envelope should contain the EMD, Tender Cost, copies of all relevant documents pertaining to eligibility criteria and second envelope should contain the tender form/the price bid. In case, the 1st envelope is not annexed with eligibility criteria in the proper format and/or is without tender fees and EMD, the envelope marked 2, (Price bid) will not be opened and the same will be rejected and no representation shall be entertained in this regard. - m) Each bidder can submit only one bid in sealed envelopes. Bidder submitting more than one quotation for the same package will not be entertained.
- n) All duties, taxes, and other levies, including the transportation expenses, are payable by the Supplier/Agencies/Company under the contract and shall be included in the total price.
- o) The bidders will comply with the terms and conditions mentioned in the tender document and accordingly clearly fill all the columns in both the formats (Technical & Financial), failing which the Institute reserves the right to reject the same.
- p) Incomplete filled-in tenders shall be rejected.
- q) The bid shall be opened as scheduled in the Notice Inviting Tender (NIT), in the presence of bidders or their authorized representatives, if any.
- r) In case, there is a Public Holiday on the scheduled date/day of opening the bid, the same shall be opened on the next working day at the same time.
- s) The bidders are expected to visit the site at the Institute to inspect the proposed work and be aware of the site conditions and scope of work, which is to be declared in the tender form.
- t) No correspondence shall be made with those bidders, whose bids are rejected on technical or financial basis.

# 8. Opening of NIT:-

Date and timings for the opening of the NIT is scheduled for 28/07/2024 at 5:00 PM in Room No. B-105/106, ABV-IIITM Gwalior.

# 9. Selection Criteria:-

The work will be awarded to L1 vendor on overall basis of the work by ABV-IIITM, Gwalior. The determination of lowest bidder will NOT be on individual rates of financial bids, rather it will be on overall basis.

# 10. Evaluation quotations:-

The purchaser/members of the committee will evaluate and compare quotations determined to be substantially responsive, i.e., they should be properly signed & conform to the terms, conditions, specifications, and qualifications.

# 11. Award of Contract: -

- **I.** The purchaser will award the contract to the bidder whose quotations has been determined to be substantially responsive, and who has offered the lowest evaluated quoted price. Notwithstanding the above, the purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.
- II. The bill in triplicate may be sent to this office for settlement after satisfactory delivery, installation and commissioning of the material. The bill should have full particulars of the items. No Payment shall be made in advance nor shall the loan from any financial institutions be recommended on the basis of the order of award of work. The Contractor shall submit the bill only after satisfactory delivery, installation, and commissioning of the material to the satisfaction of the ABV-IIITM, Gwalior. The case of issuing a sanction and passing a bill for payment will be initiated on receipt of the inspection report. No payment will be made for goods rejected. The actual quantity of items executed will be paid quantities mentioned in the BOQ (Financial Bid), which may be increased or decreased during execution.

# 12. Performance Security: -

II. The Performance Security shall be refunded after 03 Months defect liability period from the date of successful completion of work and satisfaction of the Institute. No interest shall be paid in such refund.

# 13. EMD of unsuccessful bidders: -

The EMD of unsuccessful bidders will be returned after the finalization of the tender. No interest shall be paid in such refund.

# 14. The EMD shall be forfeited if:

- a) The bidder withdraws his bid during the period of bid validity.
- b) In the case of a successful bidder, if he fails to furnish the required Security Deposit within the specified time limit.
- c) The bid shall remain valid for a period of **120 days** from the date of receipt of the bid.
- d) No charges for artwork will be paid under any circumstances.

# 15. Defect liability period: -

The work/ materials of the contractor shall be under a **3-month Defect Liability Period (DLP)**. Any defect(s) noticed during the defect liability period shall be rectified by the contractor without any cost to ABV-IIITM, Gwalior, failing which the Security /Performance guarantee Deposit of the Contractor shall be forfeited. If the contractor backs out of the work tender, the EMD deposited by the contractor shall be forfeited. The contractor may also be debarred from any future tendering process in the institute for reasons assigned hereinabove.

# 16. Duration of work completion: -

The work should be started mandatorily within three days from the date of receipt of the Work Order. The work shall also be duly completed within **45 Days** from the date of receipt of the work order by the agency.

# 17. Liquidated damages/penalty for delay:-

If the contactor fails to complete the work within the stipulated time or time extended by the Institute (if any) liquidated damages at the **rate of 0.50% per week (07 days) of delay subject to maximum of 10% of the total contract value** shall be deducted and recovered from the contractor. If any hurdle arises, the same may be intimated to the office of the **Dean of Planning and Development/Associate Dean Physical Infrastructure**, and accordingly, extension of the time period shall be made, if required.

#### 18. Penalties for Damages Due to Various Reasons:-

The contractor shall be held responsible for any damage caused to equipment, facilities, or thirdparty property due to negligence, improper handling, installation errors, or non-compliance with safety protocols. The following penalty structure shall be applicable:

- a. Minor damage (repairable onsite): ₹10,000 per incident.
- b. Moderate damage (requiring equipment replacement or extended downtime): ₹50,000 per incident.
- c. Severe damage (leading to safety hazard, major financial impact, or legal action): ₹2,00,000 per incident plus cost of rectification and any compensation due to ABV-IIITM Gwalior or affected parties.
- d. **Delays resulting from such damages** will attract an additional penalty of ₹5,000 per day beyond the scheduled completion date.

# 19. Specification:-

The materials supplied and proposed to be used in the work shall be of requisite specifications as specified in NIT, as per specification given in BOQ (financial bid), and as per the approved list

#### 20. Payment:-

- a) Payment will be made after satisfactory completion & handing over of the entire work and bill submitted by the Contractor. Applicable GST/TDS or any other statutory deduction, penalties, liquidity damages, if any, etc. shall be deducted from the amount payable to the contractor.
- b) Payment shall be made after the supply and submission of bills, which will be subject to satisfactory supply (certified by the committee constituted for the purpose). Engineer in Charge will certify the quality and quantity of the items supplied/ work done as per specifications and recommend accordingly the extent of payment.

#### 21. Bill of quantity: -

The quantities of work given in the bill of quantities (BOQ) (financial bid) are approximate to give an idea of work. The BOQ (financial bid) is attached as **Annexure-V** in this document. Work shall be carried out as per the given design/ specifications, and the quantities may vary on the higher or lower side. The contractor shall execute the varied quantity of work on the quoted rates. The payment shall be made as per the actual measurement of work.

#### 22. Tools and tackles:-

All tools, tackles, and other equipment as per the requirement of work will be arranged by the contractor, and their charges will be deemed to be included in the quoted rates; no extra payment shall be made for the same to the Contractor.

#### 23. Risks:-

Contractor shall be solely responsible for the safety of his workers, working at the site by following all safety norms in the trade. All risks of loss or damage to physical property and of injury and death which arise during and in consequence of the performance of the contract, other than the excepted risks, are the responsibility of the contractor.

#### 24. Failure:-

Failure of the contractor to comply with the requirements of the contract shall constitute sufficient grounds for cancellation of the award and forfeiture of the Security deposit, in which event ABV-IIIM Gwalior may get the work done at the risk & cost of the Contractor.

#### 25. Work order/contract agreement: -

ABV-IIITM, Gwalior will notify the successful bidder that his tender has been accepted and it will send a work order to the bidder describing the works to be carried out and the same shall be returned duly acknowledged affirmatively by the bidder as a token of acceptance.

#### 26. Right to accept or reject the tender: -

The Director, ABV-IIITM, Gwalior, reserves the right to accept or reject any or all the tenders without assigning any reason thereof.

#### 27. Safety:-

The contractor shall make all the arrangements for the safety of his staff. The ABV-IIITM Gwalior shall not be responsible in any way for injury/disablement, accident to any workman on this account and will be free from any legal bindings in this regard. # 31. Site Preparation:-
