

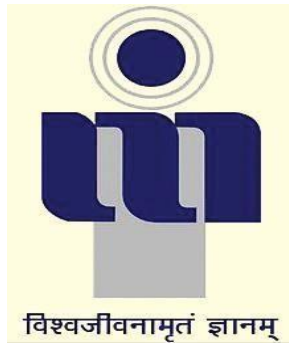

5. PENALTY CLAUSE

Liquidated Damages:

In case of delay in supply, installation and commissioning by the stipulated date, ABV-IIITM. Gwalior reserves the right of imposing penalty @ 0.5% per week on the overall value of the order subject to maximum 10% of the total cost of work order.

6. OTHER TERMS AND CONDITIONS

6.1 Termination for Insolvency:

- a) The ABV-IIITM Gwalior may at any time terminate the Contract by giving a written notice to the awarding firm, without compensation to the firm, if the firm becomes bankrupt or otherwise insolvent as declared by the competent Court, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the department.
- b) The courts of Gwalior alone will have the jurisdiction to try any matter, dispute or reference between the parties arising out of this purchase. It is specifically agreed that no court outside and other than Gwalior Court shall have jurisdiction in the matter.

6.2 Force Majeure:

- c) Should any force majeure circumstances arise. each of the contracting parties be excused for the non-fulfilment or for the delayed fulfilment of any of its contractual obligations. if the affected party within 15 days of its occurrence informs in a written form the other party.
- d) Force Majeure shall mean fire. flood, natural disaster or other acts such as war, turmoil,

6.3. Arbitration & Jurisdiction:

- a) That in case of any dispute between party of first part and the party of other part arising out of or in relation to the agreement, the dispute shall be referred to arbitration of a sole arbitration to be appointed by the Director, ABV-IIITM Gwalior. The award of the said arbitrator shall be binding on both parties.
