
Procedure for Payment of Semester Registration Fees (Jan 2018-June 2018) using SBI Collect

Instructions for students who have taken Educational Loan from Banks:


- 1. Visit the link:https://www.onlinesbi.com/prelogin/icollecthome.htm?corpID=835537


